As per the application number 6100019240 received under the subject, the site inspection of the building constructed at the applied site was done in reference to the approved fire plan by the qualified/eligible officer of the department by operating the fire equipment in the presence of the fire engineer consultant and the owner (applicant) of the building.

The arrangements of fixed portable fire fighting, manual automatic awakening detection systems, first aid fire fighting Utiliations installed in the building were found to be operational and as per the prescribed standards at the time of site inspection.

Thereafter, the case was examined as per the inspection report received, as per the above, the proposal received for Fire Plan Approval has been found suitable.

Fire Safety Certificate is issued under the following provisions/conditions

- It is mandatory to keep MOS open as per approfed map of the building for unobstructed movement of fire vehicle.
- 2. It shall be mandatory that all portable and fixed fire fighting systems installed in the building are kept in operational condition at all times and their record is duly maintained as per the standard/rules.
- 3. It shall be mandatory for the applicant/owner to maintain the fire fighting equipment installed in the building as per the prescribed IS standards within the stipulated time period and to appoint qualified staff for the maintenance.
- It shall be mandatory to maintain the fire fighting equipment as per the prescribed standards.
- 5. It shall be mandatory to provide training to all the staff working/available in the building for operation of fire fighting equipment installed in the building.

- 7. It will be mandatory for the applicant/owner to follow the provisions mentioned in the inspection report as well as other necessary provisions and IS standards prescribed in Part 04 of National Building Code 2016 for fire safety. If these provisions are not found to be followed during the site inspection, the fire authority will have full authority to cancel the Fire Safety Certificate.
- 8. It will be mandatory to submit the application for the Fire Safety Certificate and by 30th June of every financial year, an undertaking will have to be submitted along with the fire audit report that all the fire safety uipment is working properly.
